APUSA is committed to operate within the spirit and letter of all laws and regulations affecting its businesses and employees.

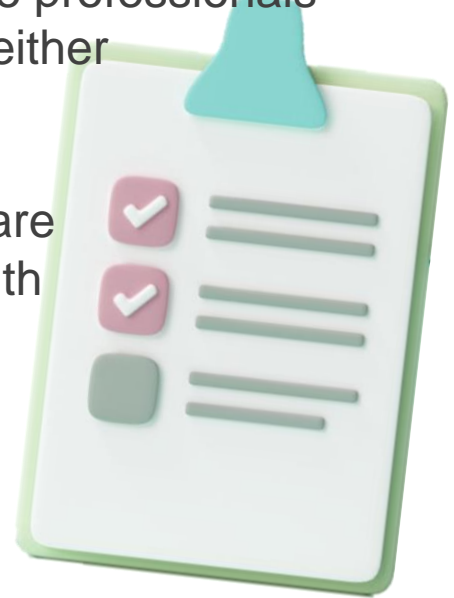
Employees must exercise the highest level of integrity, ethics and objectivity in their actions and relationships which may affect the Company.

All materials used to communicate information to customers are accurate, truthful, complete, not misleading, and compliant with all applicable US laws and regulations.



APUSA CODE OF CONDUCT

- 1 ● Hold paramount the safety, health and welfare of the public in the performance of professional duties.
- 2 ● Act in such a manner as to uphold and enhance personal and professional honor, integrity and the dignity of our profession.
- 3 ● Treat with respect and consideration all persons, regardless of race, religion, gender, sexual orientation, marital or family status, disability, age or national origin.
- 4 ● Comply with applicable federal, state and local laws, regulations and fiduciary responsibilities in an effort to create transparency in all of our operations.
- 5 ● Provide credible and effective oversight to the organization's work without personal bias.
- 6 ● Engage in carrying out Aurobindo's mission in a professional manner.

- 7 ● Conduct organizational and operational duties with positive leadership exemplified by open transparent communication, creativity, dedication, and compassion.
- 8 ● Serve with respect, concern, courtesy, and responsiveness in carrying out the organization's mission.
- 9 ● Demonstrate the highest standards of personal integrity, truthfulness, honesty, and fortitude in all activities in order to inspire confidence and trust in such activities.
- 10 ● Abide by the governing documents and policies of the Company.
- 11 ● Collaborate with and support other professionals in carrying out our mission.
- 12 ● Build professional reputations on the merit of services and refrain from competing unfairly with others.
- 13 ● Accept as a personal duty the responsibility to conduct themselves with professional competence, fairness, impartiality, efficiency, and effectiveness.

- 14 ● Avoid any interest or activity that conflicts with the conduct of their official duties.
- 15 ● Respect and protect privileged & confidential information to which they have access in the course of their official duties.

- 17 ● Not accept commissions, payments, loans, promises of future benefits or other items of value from anyone who has or may seek some benefit from Aurobindo in return, other than occasional gifts of nominal value that are in keeping with good business ethics.

- 19 ● Demonstrate the highest standards of personal integrity, truthfulness, honesty, and fortitude in all activities in order to inspire confidence and trust in such activities.
